TPP check TIPs and prepare TxDOT website	April 28 – May 11	14 days for TPP to review
TX Register Notice posted	May 12	Starts 30 public comment period
Public Hearing held week of	May 30	15+ days after TX Register posting
Public comment period ends week of	June 12	Comment period ends at COB
Earliest date for FHWA / FTA approval	June 13	First day FHWA / FTA could approve
Earliest date for opening May Revision	June 14	Open August Revision
