IV. PRESENTATION, DISCUSSION, AND ACTION ITEMS

A. Consideration and Action to Approve the Minutes of March 3, 2021

Eva Garcia, RGVMPPO BikePed Program Coordinator, asked members had a chance to review the Minutes of March 3, 2021. No corrections were noted to the minutes of March 3, 2021, Andy Vigstol (City of Harlingen) made a motion to approve minutes as presented by staff. The motion was seconded by Rene Ballesteros (Museum of South Texas History) and upon a vote; the motion passed unanimously.

B. Consideration and Action to Approve the FY2021-2022 Transportation Alternatives Set-Aside (TASA) Program Call for Projects

Information was presented a list of projects, previously awarded TASA funds, that are currently in development. Eva Garcia informed members that a total of \$2.3M was available for the FY2021-2022 TASA Program Call for Projects. A timeline of activities for the program call was presented:

- **May** – Host FY2021-2022 TASA Program Call for Projects Workshop, *May 25th at 1:30p.m.*
- **June + July** – Call for Projects opens June 1st and closes July 30th at 5:00p.m.
- **August** – BPAC reviews, evaluates and scores submitted project applications for TAC consideration
- **September** – TAC and TPB will review the scored projects and take action to award projects with TASA funding
- **October** – 30-day public involvement period for November 2021 STIP Revisions (*tentative*)
- **November** – Selected projects will be included in the November 2021 STIP Revision (*tentative*)

Eva Garcia, RGVMPPO BikePed Program Coordinator asked members if they wanted to make any revisions to the timeline of activities. With no corrections needed, Rene Ballesteros (Museum of South Texas History) made a motion to approve the FY2021-2022 TASA Program Call for Projects. The motion was seconded by Javier de Leon (TPWD Estero Llano Grande SP) and upon a vote; the motion passed unanimously.

C. Review and Discussion on TxDOT's Texas Bicycle Tourism Trails Study
