#### IV. PRESENTATION, DISCUSSION, AND ACTION ITEMS

#### A. Consideration and Possible Action to Approve the Minutes of August 4, 2021

Eva Garcia, RGVMPO BikePed Program Coordinator, presented the Minutes of August 4, 2021. BPAC Member Frank Gudino (City of Brownsville) made a motion to approve the Minutes of August 4, 2021. The motion was seconded by Omar Anzaldua (City of Pharr) and upon a vote; the motion passed unanimously.

#### B. Consideration and Possible Action to Approve the Minutes of September 1, 2021

Eva presented the Minutes of September 1, 2021. BPAC Member Frank Gudino (City of Brownsville) made a motion to approve the Minutes of September 1, 2021, with the recommended changes. The motion was seconded by Craig Wuensche (TxDOT) and upon a vote; the **motion passed unanimously**.

#### c. Discussion & Possible Action regarding RGV Bicycle & Pedestrian Count Data Program

Eva shared a list of municipalities/trails that were allocated for eco-counters and introduced RGVMPO Planner I Chris Nelson. Chris provided BPAC Members with a program update and shared that some information on the installed counters was still needed – specifically, the wiring/directional details. Chris shared that we were working on getting all the information to share with Eco-Counters to set up the Eco-Visio API. Additionally, Chris advised the participating municipalities that he would be emailing the MOU Amendments for consideration/signatures. Members were given the opportunity to discuss and ask questions. **No action was taken**.

#### D. Discussion & Possible Action regarding RGV B-Cycle BikeShare Program

Horacio Garza, Regional Bikeshare Coordinator with the LRGVDC, shared that he and Executive Analyst, Sarah Dierlam, manage RGV B-Cycle. Horacio provided BPAC Members with the history of the program, sharing that the program expanded from McAllen (8 stations) and is now also available in Harlingen (4 stations) and Brownsville (5 stations). There are a total of 17 stations with 110 bikes. Membership options include hourly (\$2), daily (\$6), weekly (\$15), monthly (\$30) or annual (\$65). Riders can pay through the mobile app or the station kiosks to check out a bike. Horacio reported on membership sales for the last 4 months, and rider trips in 2021. Bikeshare goals include reduce transportation costs, increase overall physical activity, improve quality of life, attract new riders/visitors to explore the RGV, and provide affordable access to recreational activities for families. RGVMPO BPAC Members provided their thanks and input to Horacio on his presentation. One shared idea was to consider the potential of bundling transit passes with bikeshare membership. **No action was taken**.

#### E. Discussion & Possible Action regarding the RGVMPO BPAC Membership

Eva reviewed the updates to the RGVMPO BPAC Membership website and showed which members needed to identify alternates.. It was presented that the BPAC had the following membership vacancies:

- Economic Development Agency (1)
- Pedestrian-Oriented Agency (2)
- o Advocate Agency (2)
- Bicycle-Oriented Agency (1)

BPAC Members were notified that a Membership Application was received from David Warren Hernandez, who is the Valley Off-Road Bicycling Association (VORBA) Founder/Director. BPAC Member Richard Cavin (Citizen At-Large) made a motion to approve Mr. Hernandez's membership application to serve a two-year term on the RGVMPO BPAC. As a representative of VORBA, Mr. Hernandez will be filling the Bicycle-Oriented Agency vacancy. The motion was seconded by Rene Ballesteros (Citizen At-Large) and upon a vote; the motion passed unanimously.

F. Discussion and Possible Action regarding RGVMPO Category 9: TASA Program Funds

Eva Garcia, RGVMPO BikePed Program Coordinator, provided members with an update on all RGV TASA funds
and projects. Eva reviewed the federal process for TASA funds and gave a high-level overview of the process
from application to project development. Eva then provided status updates on funding from FY2017 to the
recently awarded project. She highlighted that a resolution to re-program funds would be presented to the
RGVMPO Transportation Policy Board, and that the City of McAllen's Jackson Rd. Hike and Bike Trail Project
was being recommended to ensure the obligation of funds. Sarah Dierlam, LRGVDC Executive Analyst shared
with BPAC members that LRGVDC is actively looking for other grant opportunities/funding sources to continue to
expand the regional bikeshare program (with B-Cycle as the provider) that is still relatively cost-friendly for
municipalities. No action was taken.

#### V. PROJECT UPDATES

- **A.** Frank Gudino, City of Brownsville, notified members that the **West Rail Trail** and **Southmost Nature Trail** received Letters to Proceed and will be procuring construction/contractor services soon.
- **B.** Adrienne Wheatly, Caracara Trails, notified members that the **Bahia Grande Feasibility Study** is currently soliciting public input via an interactive map (<a href="www.caracaratrails.org">www.caracaratrails.org</a>). The Study is expected to be completed April 2022.

#### VI. NEW OR UNFINISHED BUSINESS – NONE

**A.** BPAC Members brought up the continued interest to have in-person meetings, potentially hybrid. This will be considered as an item for the next BPAC meeting.
